Perkins IV. The Carl D. Perkins Career and Technical Education Act of 2006 (Perkins IV) is a principal source of federal funding to states and discretionary grantees for the improvement of secondary and postsecondary career and technical education programs across the nation. The purpose of the Act is to develop more fully the academic, career, and technical skills of secondary and postsecondary students who elect to enroll in career and technical education programs.

New Jersey's Perkins V State Plan – Adopted 2020 Comprehensive Local Needs Assessment A new requirement for local eligible recipients to receive financial assistance from the Strengthening Career and Technical Education for the 21st Century Act, is to conduct a comprehensive local needs assessment (CLNA) and to update it at least every two years.

As set forth in Perkins, the main priority is to close the achievement gap for special populations on the Perkins core indicators of performance.

The Federal Perkins Loan Program provides lowinterest loans to help needy students finance the costs of postsecondary education. Students attending any one of approximately 1,700 participating postsecondary institutions can obtain Perkins loans from the school.

The federal Carl D. Perkins Career and Technical Education Improvement Act of 2006 (Perkins IV) provides grants to improve the quality of career and technical education (CTE). Applications for Perkins IV extension year funds must describe how grant monies will support the development of programs that: integrate rigorous academics with career and technical instruction;

In addition to the requirements in Local Uses of Funds outlined in Section 135(b) of the Perkins V, all expenditures of Perkins funds must meet the basic cost principles outlined in the Office of Management and Budget (OMB) Circulars, the most current of which being 2 CFR 200 (the “Super circular”).
